THE PROPOSED ISSUANCE AND ALLOTMENT OF NEW ORDINARY SHARES IN THE CAPITAL OF CNMC GOLDMINE HOLDINGS LIMITED (THE "PROPOSED ISSUE")

The Board of Directors (the "Board") of CNMC Goldmine Holdings Limited ("CNMC" or the "Company") refers to the announcements dated 3 April 2012 and 12 April 2012, the circular to shareholders dated 12 April 2012 and the resolutions approved at the extraordinary general meeting held on 27 April 2012 in relation to the Proposed Issue.

The Board wishes to announce that the Company has today issued 3,000,000 new ordinary shares in the capital of the Company (the "**Performance Shares**") as performance bonus to Chia Chee Ching, Yeap Kok Seng, Lim Kwang Hui and Yang Mu (collectively, the "**Allottees**" and each an "**Allottee**") in the proportion as set out below. The Performance Shares rank *pari passu* in all respects with and carry all rights similar to all other existing issued ordinary shares in the capital of the Company.

Each of the Allottees has given an undertaking that he/she will not deal, assign, transfer, dispose or distribute the number of Performance Shares as set out below, for a period of one year from the date of the listing and guotation of the Performance Shares:-

The Performance Shares are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on 17 May 2012 at 9.00 a.m..
