

CNMC Goldmine lauded in SIAS Investors' Choice Awards 2022

SINGAPORE, 8 October 2022 – CNMC Goldmine Holdings Limited (“CNMC” or the “Company”) is the runner-up of the 2022 Most Transparent Company Award (Materials Category), an acknowledgement by the Securities Investors Association (Singapore) (“SIAS”) of its ongoing efforts to improve transparency and disclosure.

The gold producer, which operates in Malaysia’s Kelantan state, was selected for the award based on a set of criteria developed by SIAS and the NUS Business School’s Centre for Governance and Sustainability, with assistance from Refinitiv, one of the world’s largest providers of financial markets data and infrastructure.

As part of its ongoing outreach to the investment community, CNMC engages shareholders at dialogue sessions every time it releases its financial results. It also holds regular results briefings for brokers, analysts, fund managers and high-net-worth individuals.

Mr Chris Lim, the Company’s CEO, received the award at a presentation ceremony for the SIAS Investors’ Choice Awards 2022 held on 7 October 2022 at the Suntec City Convention Centre. Mr Alvin Tan, Minister of State for Trade & Industry and Culture, Community and Youth, was the guest of honour at the event.

“Mining is a high-risk business and it is vital that we have the backing of shareholders to help us succeed. With the macro environment becoming increasingly challenging and uncertain, it is only right that we be as upfront and open as we can with investors so that they can make informed decisions while we continue to court their support,” Mr Lim said.

The Group is focused on developing the Sokor Gold Field Project, located in the State of Kelantan, Malaysia. Spanning an area of 10km², the project has identified five gold deposit regions, namely Manson's Lode, New Discovery, New Found, Sg. Ketubong and Rixen.

As at 31 December 2021, the Sokor Gold Field Project had JORC-compliant gold resources (inclusive of ore reserves) of 14.99 million tonnes at a grade of 1.7 g/t in the Measured, Indicated and Inferred categories comprising a total of 800,000 ounces of contained gold. The project achieved its first gold pour on 21 July 2010. The Company also owns CNMC Pulai Mining Sdn. Bhd. and Kelgold Mining Sdn. Bhd., both of which are in Kelantan.
